



Health services in many big cities, in Britain and elsewhere, are no longer appropriate to serve populations that have moved out to the suburbs. Commissioned by the government to provide some answers to London's health care problems, the Tomlinson report raises as many questions:

- @ What are the implications of its proposals for the future of health care in London and other big cities?
- * How are the substantial improvements in primary and community health care to be brought about?
- # What support is needed for teaching and research?
